 - a. Those who filed their SALNs with complete data;
 - b. Those who filed their SALNs but with incomplete data; and
 - c. Those who did not file their SALNs.
- 3. The Chief of the HRM Division, Central Office and HRM Section in the Area Offices shall transmit all original copies of the SALNs received on or before **June 30 of every year** to the concerned offices, in compliance to CSC Resolution No. 1500088 promulgated on 23 January 2015 and Section 5 of CSC Resolution No. 060231 dated February 1, 2006.

 - "e. Declaration of real properties shall include its description, kind, exact location, year and mode of acquisition, assessed value, fair market value, acquisition cost of land, building, etc. including improvements thereon"
