

CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of ____ 20__ between PHILIPPINE POSTAL CORPORATION with principal business and office address at Manila Central Post Office Building, Magallanes Drive, Liwasang Bonifacio, Barangay 659-A, Ermita 1000, Manila, duly represented herein by its Postmaster General and Chief Executive Officer, NORMAN N. FULGENCIO, (hereinafter called "the Entity") of the one part and 2GO EXPRESS, INC. with principal business and office address at 8th Floor Tower 1 Double Dragon Plaza Building, EDSA Extension corner Macapagal Boulevard, Barangay 076, Pasay City, duly represented herein by its Account Executive JENELYN C. ESCALA, (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for general support services, particularly Conveyance by Air of Domestic Inbound and Outbound Mail Dispatches for Twenty One (21) Destinations and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of TWENTY ONE MILLION FOUR HUNDRED TWENTY SEVEN THOUSAND FIFTY PESOS (Php 21,427,050.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications/Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are



subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of TWENTY ONE MILLION FOUR HUNDRED TWENTY SEVEN THOUSAND FIFTY PESOS (Php 21,427,050.00) or such other sums as may be ascertained, 2GO EXPRESS, INC. agrees to perform and provide Conveyance by Air of Domestic Inbound and Outbound Mail Dispatches for Twenty One (21) Destinations in accordance with his/her/its Bid.
- 4. The PHILIPPINE POSTAL CORPORATION agrees to pay the abovementioned sum in accordance with the terms of the bidding.
