

CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of **MAY 11 2022** 20__ between **PHILIPPINE POSTAL CORPORATION** with principal business and office address at Manila Central Post Office Building, Magallanes Drive, Liwasang Bonifacio, Barangay 659-A, Ermita 1000, Manila, duly represented herein by its Postmaster General and Chief Executive Officer, **NORMAN N. FULGENCIO**, (hereinafter called "**the Entity**") of the one part and **MESSAGING SOLUTIONS PROVIDER, INC.** with principal business and office address at MSPI Place, 1294 Batangas Street, Barangay San Isidro, Makati City, duly represented herein by its President and COO, **JOEL G. SANTOS** (hereinafter called "**the Service Provider**") of the other part;

WHEREAS, the Entity invited Bids for general support services, particularly the **Annual Comprehensive Maintenance for Pitney Bowes Vantage Letter Sorter – 72 Bin** and has accepted a quotation from the Service Provider for the supply of those goods and services in the sum of NINE MILLION EIGHT HUNDRED THOUSAND PESOS (**Php 9,800,000.00**) (hereinafter called "**the Contract Price**").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. General and Special Conditions of Contract;
 - ii. Terms of Reference; and
 - ii. Request for Quotation
 - ii. Bidder's quotation, including the quotation after the negotiation, Technical Specifications, and all other documents or statements submitted;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.





In consideration for the sum of NINE MILLION EIGHT HUNDRED THOUSAND PESOS (Php 9,800,000.00) or such other sums as may be ascertained, **MESSAGING SOLUTIONS PROVIDER, INC.** agrees to perform and provide **Annual Comprehensive Maintenance for Pitney Bowes Vantage Letter Sorter – 72 Bin** in accordance with his/her/its offer.
4. The PHILIPPINE POSTAL CORPORATION agrees to pay the abovementioned sum in accordance with the terms of the bidding.




