

## CONTRACT AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_\_ day of \_\_\_\_\_\_ 20\_\_\_\_ between PHILIPPINE POSTAL CORPORATION with principal business and office address at Manila Central Post Office Building, Magallanes Drive, Liwasang Bonifacio, Barangay 659-A, Ermita 1000, Manila, duly represented herein by its Postmaster General and Chief Executive Officer, NORMAN N. FULGENCIO, (hereinafter called "the Entity") of the one part and FASTLINE TRADING INC. with principal business and office address at Unit 207 Victoria De Makati, Washington Street corner Dela Rosa Street, Brgy. Pio Del Pilar, Makati City, duly represented herein by its President, SAMUEL G. MADDUMA, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Various Brand New Compatible Toners/Cartridges for Pantum P2500W Monochrome Laser Printer and HP LaserJet PRO M15a (CF-248A) Printer and has accepted a Bid by the Supplier for the supply of those goods in the sum of FIVE MILLION EIGHT HUNDRED THREE THOUSAND FIVE HUNDRED PESOS (Php 5,803,500.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH A\$ FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz*.:
  - i. Philippine Bidding Documents (PBDs);
    - *i.* Schedule of Requirements;
    - ii. Technical Specifications/Terms of Reference;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>

- In consideration for the sum of FIVE MILLION EIGHT HUNDRED THREE THOUSAND FIVE HUNDRED PESOS (Php 5,803,500.00) or such other sums as may be ascertained, FASTLINE TRADING INC. agrees to supply and deliver Various Brand New Compatible Toners/Cartridges for Pantum P2500W Monochrome Laser Printer and HP LaserJet PRO M15a (CF-248A) Printer in accordance with his/her/its Bid.
- 4. The **PHILIPPINE POSTAL CORPORATION** agrees to pay the abovementioned sum in accordance with the terms of the bidding, as follows:

Staggered payment shall be made only based on staggered delivery in accordance with abovementioned schedule and upon certification by the Head of the Procuring Entity or its duly authorized representative to the effect that the goods have been rendered or delivered in accordance with the terms of this Agreement and have been duly inspected and accepted. Except with the prior approval of the President of the Philippines, no payment shall be made for the goods not yet delivered under this Contract.

The Supplier's request(s) for payment shall be made to the Entity in writing, accompanied by an invoice describing the goods delivered, and upon fulfillment of other obligations stipulated in this Agreement. Payment shall be made by the Entity not later than sixty (60) days from receipt of invoice and other necessary documents, subject to the usual accounting and auditing requirements of the Entity.
