WHEREAS, the Management Executive Committee in its Resolution No. 2022-18 dated May 26, 2022¹, recommended for approval of the Board of Directors the Revised Corporate Operating Budget of PHLPost for CY 2022, the Revised Results for

Operations, and Revised Project Procurement Management Plan due to the following considerations:

- 1. Addition to the Personnel Services for the salaries and benefits of employees due to the (i) increase in salary rate from SSL IV Tranche 4 to SSL V Tranche 3, (ii) increase in the terminal leave benefits due to the increase in the number of employees below 63 years old who tendered their retirement/resignation for the current year, and (iii) increase in other bonuses and allowance due to the increase in the number of regular letter carriers based on the positions which are priority to be filled up as proposed by the Areas; and
- Increase of budget allocation for Non-Personnel Services Accounts - MOOE and Capital Expenditure in consideration of proposed priority projects.

WHEREFORE, BE IT RESOLVED as it is hereby RESOLVED to approve the Revised Corporate Operating Budget of the Philippine Postal Corporation for Calendar Year 2022 in the amount of Five Billion Five Hundred Ten Million Seventy-Three Thousand Eight Hundred Seventy-Eight Pesos (P5,510,073,878.00) together with its supporting documents such as Results of Operations (ROO) and Project Procurement Management Plan (PPMP).

Revised Corporate Operating Budget (COB) for CY 2022

WHEREAS, the Corporate Operating Budget (COB) for CY 2022 was approved on 16 June 2020 through Board Resolution No. 2020-25 and was amended on 22 July 2020 under Board Resolution 2020-40;

WHEREAS, the Department of Budget and Management (DBM) informed the Post Office that the COB for CY 2022 can still be revised and shall be submitted not later than 30 June 2022. Below is the summary of the revised COB:

WHEREAS, two years since the pandemic disrupted operations, the Post Office installed mitigation programs to adjust to the requirements for operations. The PhilSys ID is expected to provide significant addition to the revenue and expense accounts. The Post Office have also implemented its digitalization initiatives with the Enterprise Resource Planning, the establishment of the Command Center, and upgrades in equipment to enhance postal services nationwide. There is also the need to reevaluate/recalibrate priority projects of the Corporation and its operations;

WHEREAS, taking into consideration the macroeconomic assumptions, the approved COB for CY 2022 will have to be revised and/or modified as it was prepared in 2020. Moreover, the following plans, activities, and/or projects (PAPs) require significant revision of the COB for CY 2022 as approved, to wit:

a. The Post Office entered into contract with the Philippine Statistics Authority (PSA) for the delivery of the Philippine Identification Card (Philippine ID), under the

Philippine Identification System (PhilSys) of the Philippine Government. The additional estimated expenses in the processing and delivery of Philippine ID will be included in the proposed revision of the COB FY 2022.

- b. The Post Office entered into contract with the National Printing Office (NPO) for the printing of New Postal ID (PID) with Financial Functionality. The revenue to be generated as well as the estimated expenses in the capturing and printing of the New PID with Financial Functionality will be included in the proposed revision of the COB FY 2022.
- c. Priority PAPs are re-evaluated and/or re-calibrated to address as well as adapt to the evolving requirements and need of the postal customers.
- d. The Personal Services (PS) budget will be adjusted to include the Hazard Pay of personnel that physically reported for duty during the ECQ and Modified ECQ (ECQ).
- e. The Personal Services (PS) budget will be adjusted from the existing Salary standardization Law (SSL) IV tranche 4 to SSL V Trance 3 while waiting for the GCG's instruction to implement the Compensation and Position Classification System (CPCS) under Executive Order No. 150.
- f. Reduction, increase and/or realignment of approved Budget allocated for Non-PS accounts of Maintenance and Other Operating Expenses (MOOE) and Capital Expenditure (CAPEX).

HERETO, RESOLVED, that the Post Office Executive Committee recommends to the Post Office Board of Directors the approval of the Revised Corporate Operating Budget for CY 2022, the Revised Results of Operations and the Revised Project Procurement Plan;

EXECUTIVE SUMMARY

The CY 2022 Corporate Operating Budget (COB) was approved on 16 June 2020 per Board Resolution No. 2020-25 and further amended on 22 July 2020 under Board Resolution No. 2020-40.

The Department of Budget and Management (DBM) informed the Post Office that the CY 2022 COB can still be revised and shall be submitted not later than 30 June 2022. Below is the summary of the proposed revised COB:

At the time of the preparation of the COB, external and internal environmental factors affecting the operations of the Corporation have been taken into consideration. Administrative Orders and other issuances for the payment of increase in salaries, bonuses, COVID19 initiatives, and other benefits as well as the proposed plans, activities and projects as of 31 December 2021 were the bases in the preparation.

2 years since the pandemic disrupted operations, the Post Office instilled mitigation programs to adjust to the requirements for operations. The "PhilSys ID", currently being served is expected to provide significant addition to the revenue and expense accounts. The Post Office has also implemented its digitalization initiatives with the Enterprise Resource Planning, the establishment of the Command Centre, and upgrades in equipment to enhance postal services nationwide. There is also the need to re-evaluate/re-calibrate priority projects as the corporation and its operations settle in the so called "new normal", hence, the need to revise the approved COB.

RATIONALE

Taking into considerations the macroeconomic assumptions, the approved Corporate Operating Budget (COB) for Fiscal Year 2022 (Approved COB FY 2022) of the Philippine Postal Corporation (Post Office) will have to be revised and/or modified as it was prepared in 2020, nearly two (2) years ago. Moreover, the following plans, activities and/or projects (PAPs) require significant revision of the COB FY 2022 as approved, viz.:

a. The Post Office entered into contract with the Philippine Statistics Authority (PSA) for the delivery of the Philippine Identification Card (Philippine ID), under the Philippine Identification System (PhilSys) of the Philippine Government. The additional estimated

expenses in the processing and delivery of Philippine ID will be included in the proposed revision of the COB FY 2022.

- b. The Post Office entered into contract with the National Printing Office (NPO) for the printing of New Postal ID(PID) with Financial Functionality. The revenue to be generated as well as the estimated expenses in the capturing and printing of the New PID with Financial Functionality will be included in the proposed revision of the COB FY 2022.
- c. Priority PAPs are re-evaluated and/or re-calibrated to address as well as adapt to the evolving requirements and need of the postal customers.
- d. The Personal Services (PS) budget will be adjusted to include the Hazard Pay of personnel that physically reported for duty during the ECQ and Modified ECQ (ECQ).
- e. The Personal Services (PS) budget will be adjusted from the existing Salary Standardization Law (SSL) IV tranche 4 to SSL V Trance 3 while waiting for the GCG's instruction to implement the Compensation and Position Classification System (CPCS) under Executive Order No. 150.
- f. Reduction, increase and/or realignment of approved Budget allocated for Non-PS accounts of Maintenance and Other Operating Expenses (MOOE) and Capital Expenditure (CAPEX).

REVENUE PROJECTION

The Corporate Revenue Target for FY 2022 is also the same as the approved COB FY 2022 amounted to PhP4,920,320,497.

The revenue target for Mail Services is revised to PHP2,897,331,713, to be reduced by Php188,276,786 or 6.10% against the approved target for said business lines. The decrease in the Mail Services revenue target will be from the reduced volume of Philippine ID being forwarded for delivery.

Revenue target for Logistics & Warehousing is reduced to Php61,513,527 or 23.32% reduction against the approved target. The reduction come from the on-going negotiations with prospective clients which were put on-hold pending the result of the procurement of new vehicles (wing vans) as required by clients.

There was an increase of 52.52% or Php144,595,275 under Payment and Retail Services due to increase in the volume of Postal ID. With the introduction of the New PID with financial functionality, the Post Office expects to generate more revenues from this product.

Also, the revenue generated from the Biometrics Data Service Facilities Joint Venture Agreement (BDSF JVA) is recognized in the revised Revenue Target amounting to Php 62,388,613. The revenue is from the Post Office share from the service contracts under the BDSF JVA, as extended.

EXPENDITURE ASSUMPTION PERSONNEL SERVICES

The revised PS budget for FY 2022 is proposed to be increased by PHP76,028,974 or 3.27% from the approved COB FY 2022. The following PS accounts are to be increased significantly against the approved COB FY 2022, viz.:

- 1. Terminal Leave Benefits PHP184,702,256, an increase of PHP24,192,050 or 15% due to the increasing number of regular personnel below 63 years old who are retiring and/or resigning for the current year. Note that in the approved COB FY 2022 the retirement of those regular personnel ageing 63 years and above are only considered.
- 2. Other Bonuses and Allowances PHP18,599,900, an additional budget of PHP1,153,540 or 6.61% from the approved budget to provide for the increase in the number of regular Letter Carriers which are priority to be filled up as proposed by the Area Offices.
- 3. Salaries and Wages, Contractual, Year-End Bonus and Employer's Contribution—from PHP1,813,309,449, an additional budget of PHP70,325,536 or 3.88% from the approved budget to provide for the increase in salary rate from SSL IV trance 4 to SSL V tranche 3.
- 4. Reduction in the budget of other accounts was due to the assumption that vacant positions shall be filled up based on the priority positions by Area Offices, computation of RATA rates in accordance with GAA guidelines and the deletion of budget for overtime pay for the reason that this shall be charged to the unutilized budget, if any.

NON-PERSONNEL SERVICES (MOOE)

The revised Non-PS budget for FY 2022 is proposed to be reduced by PHP74,305,019 or 2.96% from the Approved COB FY 2022.

Significant increases are from the following Non-PS accounts:

1. Accountable Forms - From PHP163,105,887 to PHP234,310,065 an increase of PHP71,204,179 or 43.65% of the approved budget. Of the net increase, PHP74,477,770

is for the increase in estimated volume and unit cost of Postal Identification card (PID) from PHP222 to PHP350 per card while a reduction of PHP172,751 was for the reduction of volume of accountable forms such as official receipts, sales invoice and others.

- 2. Training From PHP6,993,774 an increase of PHP6,006,226 or 85.88% of the approved budget based on the training programs on the competency requirements of critical positions.
- Labor and Wages From PHP344,813,829 an increase of PHP30,908,345 or 8.96% based on the actual utilization of the budget. Authority to hire of additional Contract of Service (COS) workers for the second quarter of the year as well as provision for additional COS workers for Philippine ID delivery and for the data capturing duties for the PID.
- 4. Semi-Expandable Expenses From PHP61,232,275 wherein budget is to be increased by PHP34,345,907 or 56% due to the reclassification of IT peripherals for ERP Systems with unit cost of below PHP15,000 to MOOE from CAPEX amounting to PHP89,300,000 as well as proposed additional semi-expandable equipment and furniture & fixture.
- 5. Fuel, Oil and Lubricants Expenses From PHP59,758,572 an increase of PHP28,826,459 or 48.24% of the approved budget to include the increase in prevailing price per liter of diesel and gasoline.
- 6. Rent/Lease Expenses From PHP64,540,349 an increase of PHP13,024,218 or 20.18% of the approved budget to include the additional motorcycle rental expenses for additional letter carriers, regular and COS.
- 7. Subscription Expenses From PHP12,523,034 an increase of PHP21,004,714 or 168% of the approved budget to include the UPU quarterly subscription to Post net, IPS, CDS and the like and also for ERP requirement for cyber security and data privacy.
- 8. Professional Services From PHP39,185,241 an increase of PHP23,167,481 or 59.12% of the approved budget to include the current rate of the auditing services by COA, consultancy for right-sizing and Enterprise Risk Management.
- 9. Transportation and Delivery Expense International From Php194,060,277 an increase of PHP25,939,723 or 13.37% to include the increase in rate per kilogram per destination based on the prevailing market rates.
- Other MOOE From PHP113,424,745 an increase of PHP20,111,828 or 17.73% based on prior year actual utilization, provision for joint venture expenses and COVID-related expenses.

There are also be reductions in five (5) Non – Personnel Services accounts (MOOE). The most are (1) Transportation and Delivery Expenses – Foreign Postal Administration from PHP610,438,315 a reduction of budget by PHP250,438,315 or 41.02% of the approved budget caused by significant decline in the actual volume of outbound mails for all classes (2) Communication Expense – from PHP100,356,618 a reduction of the budget by PHP46,165,938 or 46% of the approved amount (3) Transportation and Delivery Expenses – Domestic from PHP 86,114,622 a reduction of budget by PHP23,180,720 or 26.92% brought about by the decrease in air conveyance due to alternative modes such as land mail runs and sea conveyance (4) Advertising, Promotional and Marketing Expenses – PHP45,302,400 a decrease of PHP18,402,400 or 40.62% of the approved budget (5) Office

Supplies – from PHP270,141,051 a decrease of PHP16,609,233 for some office supplies that have been procured and delivered in 2021.

CAPITAL EXPENDITURE

The revised CAPEX budget for FY 2022 of PHP630,031,373 is proposed to be increased by PHP49,571,527 or 7.87% from the approved COB FY 2022.

Four (4) CAPEX accounts are proposed to be increased:

- Other Equipment and Machineries from PHP185,362,526, an increase of PHP43,378,625 or 23.40% of the approved budget based on the increase in the prevailing price of the Flat Sorting Machine and the procurement of generator set for all Area Offices and Central Office.
- Motor Vehicles from PHP83,656,350 an increase of PHP31,343,650 or 37.47% of the approved budget to include motor vehicles awarded in 2021 but for delivery in 2022 amounting to PHP43M and additional motor vehicles proposed to be procured in 2022 amounted to 67M.
- 3. Infrastructure from PHP75,300,000, approved budget to be increased by PHP12,218,557 or 16.22% for the building improvement/network rehabilitation.
- 4. Leasehold Improvement from PHP3,600,000 an increase of PHP261,374.

Also, the approved budget of three (3) CAPEX accounts are proposed to be decreased: (1) IT Equipment and Software – from PHP263,242,089 a decrease of PHP33,008,976or 12.54% of the approved budget due to the prioritized IT requirements aligned to ERP Project (2) Furniture and Fixtures from PHP15,210,408 a decrease of PHP3,621,703 or 23.81% of the approved budget (3) Provision for unforeseen CAPEX from PHP3,700,00 a decreased of PHP1,000,000 or 27.03% of the approved budget.

CORPORATE OPERATING BUDGET REVENUE AND EXPENDITURE BUDGET

The Surplus in the proposed Revised Revenue and Expenditure Budget for FY 2022 (Revised REB FY 2022) was reduced to PHP502,618, a decrease of PHP25,157,164 from the approved budget. The Total Revenue in the Revised REB FY 2022 of PHP4,920,320,497 has no change compared with the approved budget. While the Total

Expenditures is PHP5,510,073,878 an increase of PHP51,295,482 or 0.94% from the approved amount.

Of the Total Revenue, the Subsidy Income from Non-Shareholders is increased by PHP27,000,000 while the Reimbursement from National Government (NG) amounting to PHP515,256,000. This is reduced by PHP861,681 or 0.17% of the approved budget.

Of the Total Expenditure, the Operating Expenses (OPEX) of PHP3,451,484,140 is a result of the reduction of PHP62,535,642 or 1.78% of the approved budget while the Administrative, Financial & Other Expenses (ADMINEX) of PHP1,378,946,838 is a result of an increase of PHP64,259,597 or 4.89% of the approved amount. The CAPEX of PHP679,642,900 is a result of an increase of PHP49,571,527 or 7.87% of the approved budget.
