CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of 22 MAR 2024 20__ between **PHILIPPINE POSTAL CORPORATION** with principal business and office address at Manila Central Post Office Building, Magallanes Drive, Liwasang Bonifacio, Barangay 659-A, Ermita 1000, Manila, duly represented herein by its Acting Postmaster General and Chief Executive Officer, **LUIS D. CARLOS**, (hereinafter called "**the Entity**") of the one part and **ALL TRANSPORT NETWORK, INC.** with principal business and office address at No. 3 Sta. Agueda Avenue, Pascor Drive, Parañaque City, duly represented herein by its Special Projects Manager, **VERNADETTE G. VIVERO**, (hereinafter called "**the Service Provider**") of the other part;

WHEREAS, the Entity invited to submit bids for certain goods and ancillary services, particularly **Services for Conveyance of International Outbound Mail Dispatches by Air for Sixty-Nine (69) Destinations** and has accepted a Bid by the Service Provider for the said services in the sum of EIGHTY-EIGHT MILLION FIVE HUNDRED EIGHTY-TWO THOUSAND SIXTY-TWO PESOS AND THIRTY-NINE CENTAVOS (**Php 88,582,062.39**) (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications/Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as

the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


3. In consideration for the sum of EIGHTY-EIGHT MILLION FIVE HUNDRED EIGHTY-TWO THOUSAND SIXTY-TWO PESOS AND THIRTY-NINE CENTAVOS (Php 88,582,062.39) or such other sums as may be ascertained, **ALL TRANSPORT NETWORK, INC.** agrees to perform and provide **Services for Conveyance of International Outbound Mail Dispatches by Air for Sixty-Nine (69) Destinations** in accordance with his/her/its Bid.
4. The PHILIPPINE POSTAL CORPORATION agrees to pay the abovementioned sum in accordance with the terms of the bidding.
5. Liquidated Damages. The amount of the liquidated damages shall be at least equal to one-tenth of one percent (0.001) of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
6. The parties hereby warrant that they have not offered or paid, directly or indirectly, any government officials, agency or instrumentality, or employee thereof, any consideration, commission, or gift to secure this contract. Any violation of this warranty shall constitute a sufficient ground for the rescission or cancellation of this contract without prejudice to the filing of a civil or criminal action under the Anti-Graft and Corrupt Practices Act and other applicable laws.
7. In case a dispute shall at any time arise between the Entity and the Service Provider that would give rise to a right of action against a party, the parties should refer such dispute or difference to Arbitration in the Philippines according to the provisions of R.A. 876, otherwise known as the "Arbitration Law" and R.A. 9285, otherwise known as the "Alternative Dispute Resolution Act of 2004". The Entity, however, shall have the option not to refer or participate thereto, in which case, the Entity shall have the right to proceed filing an action before the courts of competent jurisdiction in the City of Manila.
