


This refers to the Procurement of Biometric Data Capture Service for Postal Card Project with ABC of 128,700,000.00.


In connection with this, Board Resolution No. 2024-119 was issued directing the Bids and Awards Committee (BAC) to proceed with the procurement projects that remained pending due to the issuance of Board Resolution no. 2024-62 dated 21 May 2024 involving the following: **(1) Procurement of Biometric Data Capture Service for Postal Card Project;** (2) Procurement of One (1) Lot of Card Printers and its Consumables; (3) Procurement of 720,000 Pieces of Pre-Printed Cards; and (4) Procurement of Brand New Compatible Toners/Cartridges for Pantum P2500W Monochrome Laser Printer and HP Laserjet Pro M151 Printer.

Taking into account this directive, the TWG respectfully recommends that the procurement activities be resumed, adjusting the timeline - considering the same to be suspended only from 20 June 2024.

The Technical Working Group further recommends that the current BAC adopts the previous resolution to recommend to the HoPE the award of contract to Filmetrics Corporation on the Procurement of Biometric Data Capture Service for Postal Card Project.



**BAC RESOLUTION NO. 2024-48**

**DECLARING THE BID OF FILMETRICS CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BID FOR THE PROCUREMENT OF BIOMETRIC DATA CAPTURE SERVICES FOR POSTAL CARD PROJECT (RE-BIDDING) PURSUANT TO SECTION 36 OF THE 2016 REVISED IRR OF R.A. NO. 9184 AND RECOMMENDING THE AWARD OF THE CONTRACT FOR THE SAID PROJECT TO FILMETRICS CORPORATION**

**WHEREAS**, the Bids and Awards Committee (BAC) in its Resolution No. 2024-33 dated 17 April 2024 resolved to declare a failure of bidding for the Procurement of Biometric Data Capture Services for Postal Card Project pursuant to Section 35(b) of the 2016 Revised IRR of RA 9184 considering that the lone bidder was declared ineligible;

**WHEREAS**, pursuant to Section 35.3 of the 2016 Revised IRR of RA 9184, the BAC shall conduct a re-bidding with re-advertisement and/or posting as provided for in Section 21.2 of the IRR of RA 9184;

**WHEREAS**, Section 21.2 of the 2016 Revised IRR of R.A. 9184 provides that the "Invitation to Bid" shall be advertised and/or posted at the following:

1. PhilGEPS website and the website of the procuring entity, if available;
2. Any conspicuous place in the premises of the procuring entity

**WHEREAS**, the BAC, in its Resolution No. 2024-35 dated 30 April 2024, approved the re-posting of Invitation to Bid commencing on 03 May 2024 for at least seven (7) consecutive days, and the complete schedule of activities is listed, as follows:

**WHEREAS**, the BAC conducted the *Pre-bid Conference* for the Procurement of Biometric Data Capture Services for Postal Card Project (Re-bidding) on 10 May 2024 in which three (3) bidders attended the said conference, namely:

1. Dermalog Identification System
2. Commerce Asia, Inc.
3. Filmetrics Corporation

**WHEREAS**, one (1) prospective bidder, Filmetrics Corporation, purchased the bidding documents for the said project as of the deadline for issuance of bidding documents on 22 May 2024 at 9:00 A.M.;

**WHEREAS**, one (1) bidder, Filmetrics Corporation, submitted its technical and financial proposals for the said project as of the deadline for submission and receipt of bids on 22 May 2024 at 9:00 A.M.;

**WHEREAS**, during the opening of bids for the Procurement of Biometric Data Capture Services for Postal Card Project (Re-bidding) on 22 May 2024 and upon preliminary examination of the technical components submitted by Filmetrics Corporation, the said bidder was found to have passed the requirements mandated under R.A. No. 9184 and its Revised IRR using non-discretionary pass/fail criterion, as follows:


