### Subject:

Procurement of Services for the following: (1) Conveyance by Air for Domestic Inbound/Outbound Mail Dispatches from CMEC to VisMin Areas and vice-versa for Twenty Five (25) Destinations, and (2) Conveyance by Air for Domestic Direct Inter-Island Exchange of Mails from Visayas to Mindanao Areas and vice-versa for Twenty (20) Destinations with a total ABC of Php 46,080,324.41

## TO ALL CONCERNED BIDDERS:

In connection with the above-captioned subject, please be informed that there are changes in the Bidding Documents, as follows:

# 1. Under OBJECTIVES

## Original

2.1 To *pick-up*, load and transport by air, all mail items including documents, parcels and logistics from Central Mail Exchange Center (CMEC), Manila going to and from Luzon, Visayas, and Mindanao.

#### **Amended**

2.1 To <u>receive</u>, load and transport by air, all mail items including documents, parcels and logistics from Central Mail Exchange Center (CMEC), Manila going to and from Luzon, Visayas, and Mindanao.

## 2. Under SCOPE OF WORKS

#### Original

4.7 SERVICE PROVIDER shall provide <u>advance</u> electronic information and transport information (Track and Trace) for the status/whereabouts of mail dispatches.

#### Amended

4.7 SERVICE PROVIDER shall provide electronic information and transport information (Track and Trace) for the status/whereabouts of mail dispatches.

# 3. Under KEY PERFORMANCE INDICATORS

#### **Original**

6.4 SERVICE PROVIDER shall collect, airlift, retrieve and deliver the mails to PHLPost at destination *points* within the agreed schedules.

#### **Amended**

6.4 SERVICE PROVIDER shall collect, airlift, retrieve and deliver the mails to PHLPost personnel at destination airports within the agreed schedules.





# 4. Under TERMS AND CONDITIONS

## Original

7.6 SERVICE PROVIDER shall forward/ deliver the mails to the final destination within 24 hours upon pick-up from PHLPost.

#### Amended

7.6 SERVICE PROVIDER shall forward/ deliver the mails to the final <u>airport</u> destination within 24 hours upon pick-up from PHLPost.

## 5. Under BID DATA SHEET

# Original

7.1 Subcontracting is not allowed.

### **Amended**

7.1 The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated in the bidding documents, but in no case more than twenty percent (20%) of the Project.
