The **Philippine Postal Corporation**, through the CY 2025 Corporate Budget approved by the Board of Directors of this Corporation, intends to apply the sum of **Eight Hundred Fifty-Three Thousand Five Hundred Pesos** (Php **853,500.00**) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of 1,500 Rolls of Plastic Twine for Tom Tying Machine. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Postal Corporation now invites bids for the Procurement of 1,500 Rolls of Plastic Twine for Tom Tying Machine. Delivery of the goods/services is required within Seventy-Five (75) calendar days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

- 4. Prospective Bidders may obtain further information from the Philippine Postal Corporation and inspect the Bidding Documents at the address given below starting **March 12, 2025** to **March 30, 2025** during office hours and on **March 31, 2025** until 9:00 A.M.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders starting March 12, 2025 to March 30, 2025 during office hours and on March 31, 2025 until 9:00 A.M from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00.
- 6. The Philippine Postal Corporation will hold a Pre-Bid Conference on **March 19, 2025** at **10:00** A.M., at the 3rd Floor Conference Room, Annex II Building, Manila Central Post Office, Liwasang Bonifacio, Ermita, Manila, and/or through video conferencing or webcasting via Google Meet application, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the office address indicated below on or before **9:00** A.M. of **March 31, 2025**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.





- 9. Bid opening shall be on **March 31, 2025** at **10:00** A.M. at the 3rd Floor Conference Room, Annex II Building, Manila Central Post Office, Liwasang Bonifacio, Ermita, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Philippine Postal Corporation reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
