BAC-AMP RESOLUTION NO. 2025-05-059

RECOMMENDING THE AWARD OF CONTRACT (PURCHASE ORDER) TO MIAMI HEAT BEACH RESORT FOR THE PROCUREMENT OF ONE (1) LOT- LEASE OF VENUE, MEALS AND ACCOMMODATION FOR THE CONDUCT OF "PHLPOST MAIL OPERATIONS DIAGNOSTIC WORKSHOP LINKAGE CONFERENCE" ON MAY 13-16, 2025, WITHIN THE PROVINCE OF BATAAN

WHEREAS, there is a request for procurement from APMG for Operations for one (1) lot- lease of venue, meals and accommodation for the conduct of "PHLPost Mail Operations Diagnostic Workshop Linkage Conference on May 13-16, 2025, within the Province of Bataan with Purchase Request No. 05-25-035 dated 05 May 2025;

WHEREAS, the Approved Budget for the Contract for the aforementioned procurement project is Nine Hundred Eighty-One Thousand Three Hundred Pesos (PhP981,300.00) based on Budget Available Control No. 25-05-122 dated 06 May 2025 (stamped/indicated in the approved PR);

WHEREAS, to invite prospective bidder/s, this procurement opportunity was posted Post Office websites as well as at bulletin board located at Post Office premises. The Request for Quotation was also sent to prospective suppliers, namely: (1) White Rock (2) Miami Heat Beach Resort, (3) Bataan White Corals, (4) Magarra Hotel, (5) Morong Star Hotel, and (6) Verdeazul Leisure Resort. However, only one (1) bidder submitted quotation: Miami Heat Beach Resort.;

WHEREAS, per eligibility check during the opening of quotation/s held on 08 May 2025, the lone participating bidder was determined as "Passed" for having submitted complete eligibility documents. Hence, its financial offer was opened;

WHEREAS, the total bid of Miami Heat Beach Resort is PhP938,835.00;


WHEREAS, per Committee/end-user evaluation, the price quotation of Miami Heat Beach Resort amounting to Nine Hundred Thirty Eight Thousand Eight Hundred Thirty Five Pesos (PhP938,835.00), inclusive of all taxes and fees, which is within the ABC, is considered as the most advantageous to the government, thereby rendering the same as the single calculated and responsive offer (per attached Bid Evaluation Sheet);


WHEREAS, Item V(D)(8)(b)(vi) of Annex "H" of the 2016 revised Implementing Rules and Regulations of RA No. 9184 provides that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the PHLPost BAC-AMP hereby resolve to recommend to award the Contract (Purchase Order) to **Miami Heat Beach Resort** for the "**Procurement of One (1) lot- Lease of venue, meals, and accommodation for the conduct of "PHLPost Mail Operations Diagnostic Workshop Linkage Conference"**", with a total amount of **Nine Hundred Thirty Eight Thousand Eight Hundred Thirty Five Pesos (PhP 938,835.00)**, inclusive of all applicable taxes and fees, through alternative method of procurement (Sec. 53.10- Lease of Property or Venue - 2016 Revised IRR of RA 9184).




